ELIMINATE DR. WAITING-ROOM TIME



Your doctor's appointment was scheduled for 3 P.M. Now, an hour later, you're still cooling your heels in the reception area. If long doctor's office waits are making you ill, here's the solution on how to lose wait time fast:

- 1. Book Smart Try to book your doctor's visits for first thing in the morning or right after lunch, when physicians are less likely to be held up by other patients. And avoid "Manic Mondays" when the waiting room will be crammed with all the people who got sick over the weekend.
- **2. Less means more-** If your doctor works in a large practice, schedule for the day when the least number of physicians are working. Bigger offices often share staffs of nurses, assistants and receptionists. That means that the more doctors in the office, the more overwhelmed and backed up their staff could be.
- 3. Check up on her- Thirty minutes to and hour before your appointment, call your doctor's assistant to see if your physician is running late. If so, ask for and estimate of what time she will be ready to see you.
- 4. Don't assume your M.D. has ESP- Let her know how long you waited. Then if the situation doesn't improve by your next visit, consider shopping around for a new doctor who stays on schedule. It is important that you have physicians who value your time as much as they value their own.







SHOULD YOU RAISE OR LOWER YOUR SALARY EXPECTATIONS?

*FIND OUT WHAT YOUR INDUSTRY PEERS ARE MAKING.

Web sites like The Riley Guide (www.dbm.com/jobguide) offer link to salary surveys and raise statistics. You can also check newspapijob listings to compare what employers in your field are offering.

*KNOW WHAT A "NORMAL" RAISE at your company is. The average annual raise nationwide is now 4 to 4.5%, but your particular employer may be giving much more or less. Ask a human resources officer in your company what the average raise is for a person at your level. It shouldn't be top secret information.

*DETERMINE YOUR WORTH. If you're going to be rewarded at a higher rate, you have to show your boss that you're making less than people in similar positions, yet you're producing more. If your boss won't budge, see if he or she will supplement your salary with other benefits, such as more vacation days. Kathleen Hirce



- You quit your last job Explain that you had decided to hunt for your dream job, but couldn't do so from you old office. You had felt uncomfortable and
 - time-restricted, so you eventually left your company. Avoid offering per-
- sonal excuses, such as a family illness, or having to quit. Interviewers look down on employees who let emotional issues interfere with their work.


